




# Below is a snapshot of our 2022-2023 Special Education Programming supporting the Bureau of Special Education by topic from July 1, 2022 – March 31, 2023

#### **Updates on Other New Programming**

#### • DMHAS School-Based Center for Prevention, Education and Advocacy ("The Center")

- SERC, in collaboration with DMHAS, has invited all school districts to participate ina statewide survey to gather and share information regarding the prevention programs that Connecticut school districts are implementing around mental health, suicide prevention, substance use prevention, and social-emotional learning. The survey covers which programs are being used, the impacts of the programs, and prevention priorities for districts.
- Responses were received from 41 districts that have expressed an immediate interest in having support in the area of prevention.
- Outreach to these districts have begun to coordinate services and programming, and a Canvas course has been developed to provide additional support.
- Plans are underway for a virtual half-day Prevention Summit on May 18 to connect schools to celebrate the new center and foster collaboration and partnerships between schools and community partners.
