


# 2022-2023 Special Education Programming supporting the Bureau of Special Education as of June 30, 2023 Snapshot of IDEA Activities by Project

## Update on African American. Black. Latino. and Puerto Rican Course of Studies August 2023

#### Showcase - June 2, 2023

Educators, students, families, and invited stakeholders attended a virtual showcase of course implementation, which highlighted student voice, artifacts, and input on the impact of learning over the year. Presentation recordings and materials are posted on the curriculum webpage at <a href="https://ctserc.org/pa1912">https://ctserc.org/pa1912</a>. Fifteen schools presented, including: Wooster School, Danbury; New London Multi-Magnet High School; Wolcott High School; Bridge Academy, Bridgeport; Fairfield Ludlow High School; Suffield High School; Ledyard High School; Abbott Tech High School; Portland High School; East Lyme High School; Norwich Free Academy; and Masuk High School, Monroe.

An evening in-person reception was held at SERC's new location in Waterbury for stakeholders and community members to observe and reflect on students' culminating projects from various high schools across the state. This networking opportunity highlighted the value of the course, its impact on students, and the dedication and growth of the teachers who taught it.

#### Leadership Launch – June 7, 2023

The Leadership Launch provided district and school leaders who will implement the course in the coming year with an overview of the curriculum, including sample units, lessons, materials, and best practices and protocols for supporting staff and students. Techniques for marketing the course were shared to ensure course availability for all students.

#### Summer Institute - July 31- August 4, 2023

22 participants attended a 5-day training, with 2-days in-person/3-days virtual Content focused on curriculum overview, GoOpenCT platform, pacing plan, curriculum pedagogy, creating safe and accountable learning spaces, cultural humility, using universal design for learning, and translanguaging to support access for all learners.

Presentations by Content Experts and Implementing Teachers were provided for Semester 1, Unit 1: African Origins, Unit 2: How African Americans Persisted: Slavery and Freedom Stories of Resistance and Agency (1619-1819), Unit 3: Black Literacy, Organizations, and Liberation (1820-1865). Guest Speakers included: Dr. Benjamin Foster, Jr., CCSU; Carmita Hodge, Asst. Principal, Fitch High School, Groton; Dennis Culliton, Executive Director, Witness Stones Project; Dr. dann j. Broyld, Professor, University of Massachusetts, Lowell; Jeremy Timperanza, Social Discovering Amistad, and Chris Menapace, Education Director, Discovering Amistad.

#### Next Steps:

- VIP Teacher Days at Discovering Amistad will continue through October.
- Planning started for a Student Summit in December 2023.
- Based on Cohort 1 and Cohort 2 feedback, Advanced Topic and Coaching sessions are currently being planned to provide continued support for lesson development.
- Quarterly Training and Coaching will resume for Cohort 3 in September.

# **Other Programming Updates**

## • DMHAS School-Based Center for Prevention, Education and Advocacy ("The Center")

- SERC, in collaboration with DMHAS, surveyed all school districts to gather and share information regarding the prevention programs that Connecticut school districts are implementing around mental health, suicide prevention, substance use prevention, and social-emotional learning. The survey covered which programs are being used, the impacts of the programs, and prevention priorities for districts.
- 50 districts completed the survey, and outreach to these districts began to coordinate services and programming, including the development of an online Canvas course called Universal Opioid and Other Substance Use Prevention Planning
- Outreach to school districts is continuing with the start of the new school year. Bilingual brochures and posters are being sent to school districts this week.
- Prevention Summit took place on May 18 to connect schools to celebrate the new center and foster collaboration and partnerships between schools and community partners.
- The SERC Library serves as a central repository for substance use prevention curricula and school-centered, evidence-based programs, resources and tools for K-12 educators

## • English/Multilingual Learner Programming

- New Podcast series titled *Learning with Multilingual Students* where we hear from immigrant-origin students in Connecticut about their experiences and perspectives. Educators who are working to recognize, engage, and extend the linguistic resources of English Learner classified students will also be featured.
- The first episode is scheduled to launch on September 1 and will feature newlyarrived immigrant students at a New Haven high school sharing about their schooling experiences in Connecticut and their future goals. Bilingual school leaders provide context about successes and challenges.

## • SERC Quarterly Newsletter

• With support from Graustein and The Narrative Project, SERC will launch the first of its quarterly newsletters in early September highlighting resources, events, activities, and opportunities.

## • National Summit for Courageous Conversation®

 SERC will be represented at the 13th Annual National Summit for Courageous Conversation® taking place in Austin, Texas, from November 5-8, 2023. The Summit is an excellent opportunity for racial equity leaders from across the nation to convene and engage in deep conversation about race and its impact on opportunity and achievement for all.
