- ✓ Evidence of their ability to make a difference in their local school and/or community; and
- ✓ Dedication and advocacy to ensure equity for all parents and their children.

A complete nomination package should include the following:

1. Nomination Entry Form (attached)
2. Letter of Nomination (1 page limit) *\*Please include in the letter the nominator's relationship to nominee, contributions and areas of involvement of the nominee, and evidence of the impact of their involvement on children and families.*
3. Biography of Nominee (1 page limit)
4. Two Letters of Support (1 page limit each) *\*Letters of support can be from schools, community organizations, or individuals who know of the nominee's active involvement; it should include specific examples and evidence of the impact and contribution made by the nominee to a local school and/or community organization because of their involvement and engagement.*

Nominators and awardees will be notified no later than November 7, 2019 and invited to attend a recognition award celebration held on Thursday, November 21, 2019 in Hartford. Please submit completed nomination packages to SERC by Wednesday, October 30, 2019 to the attention of:
